## OFFICIAL INFORMATION REQUEST FOR INFORMATION ABOUT DOG CONTROL

I refer to your request of 24 August 2022 for the following information:

The period I would like information for is 1 Jan 2017 - 31 July 2022:

- 1. The number of registered dogs in your local authority, broken down annually and by month
- 2. The number of dog attacks on people council has recorded, broken down annually and by month
- 3. The number of dog attacks on people council has recorded, broken down by whichever way you categorise the severity of an attack, annually and by month
- 4. Among all the possible interventions on the attacking dog following an attack, please list how many of each of those interventions were taken, annually and by month (please also include for how many there was no intervention)
- 5. Among all the possible consequences for the dog owner following an attack, please list how many of each of those were taken, annually and by month (please also include for how many there was no consequence)

On 19 September 2022, you indicated that you no longer require the information to be broken down by month.

- 2. Please refer to the dog control activity report, referred to above.
- Dog attacks are not categorised by severity. Council records and investigates all reported dog attacks on humans and each incident is dealt with according to the facts of the particular incident.
- 4. and 5. please refer to the table below. In relation to your question about no interventions or no consequences where a dog attack on a human has occurred and it is possible to identify the owner of the dog, enforcement action is always taken either against the dog, dog owner, or both. In some cases, an incident might be reported as a dog attack, but upon investigation it becomes clear that no attack occurred. It may not always possible to identify the owner of the attacking dog for example, because the owner/dog is no longer present at the scene, or the description provided to regulatory staff is too vague for identification purposes.
