# 6 PRESENTATIONS

#### 6.1 Waka Kotahi Update

Waka Kotahi Representative, Emma Speight, provided a PowerPoint presentation which is available on Council's website in the Minutes Attachment document. Ms Speight highlighted:

Ms Speight answered questions regarding:

- Ruby Bay Bypass frequency of road condition checks Ms Speight to follow up
- SH6 Wangamoa recovery contractors Ms Speight to follow up and inform Councillor Courtney
- Speed Management Plan process and timeframe
- Coordination between the Speed Management Plan and State Highway Management Plan and possible inconsistencies in rural areas
- Concerns regarding speeds by Auckland Point School on SH6 Ms Speight to find out about that section of SH6 and inform Councillor Courtney
- Resilience work would be ongoing on the riverbank side of Devil's Bluff cliff.

# 7 REPORTS

# 7.1 Proposed Regional Land Transport Plan (RLTP) Changes August 2023

Tasman District Council Transportation Planning Advisor, Jane Murray, and Nelson City Council Transport Manager, Drew Bryant, presented the report and explained the rationale for the proposed variations.

Questions and discussion included:

- A possible future Motueka passing lane viability would depend on volumes, this could be looked at in the future, a slow vehicle passing lane may be more suitable
- Safety funding was available, this had been reallocated from work not able to be completed in the north island
- Bus interchange funding requested for this financial year was for design work, construction work would be included in Nelson City Council's Long Term Plan (LTP)
- The new RLTP would cover funding past this financial year.

# Moved Deputy Mayor O'Neill-Stevens/Councillor Courtney NTRTC23-08-4

#### That the Joint Nelson Tasman Regional Transport Committee

- 1. receives the Proposed Regional Land Transport Plan Changes August 2023 report; and
- 2. recommends to the Joint Committee of Tasman District and Nelson City that it approve variations to the Te Tau Ihu Regional Land Transport Plan to include the following projects, starting in 2023/24:
  - a) State Highway 60 Harley Road to Mapua Drive Median Barrier \$3m; and
  - b) State Highway 60 Mapua Drive to Maisey Road Widening and Safety \$3m; and
  - c) Nelson City Centre Bus Interchange as a significant project, \$5m (increase of \$3m).

# 7.2 Public Transport

Mr Bryant spoke to the background of the report and answered questions regarding:

- The rationale for the proposed change to the Transport Advertising Guidelines about alcohol advertising on buses the guidelines currently classed alcohol with tobacco, and this proposal moved it out to be a standalone item, the Councils have their own functions, for example, the Wine and Beer Festival, and would like to advertise them on buses, this was not possible under the current guidelines
- Concerns this could lead to undesirable alcohol advertising this would be brought back to the Committee if advertising went beyond what was intended
- Confirmation that the contractor purchased and supplied the eBus fleet, not Council.

# Moved Councillor Dowler/Ms Speight NTRTC23-08-5

That the Joint Nelson Tasman Regional Transport Committee:

- 1. receives the Public Transport report; and
- 2. approves retrospectively the half-price NBus fares from 1 July to 31 July 2023 noting that this attracts an additional cost of around \$50,000 split between Nelson City Council and Tasman District Council (77%/23% split); and
- 3. recommends that Nelson City Council approves increasing the public transport budgets by \$38,500 to cover the half-price NBus fares from 1 July to 31 July 2023; and
- 4. notes that Tasman District Council staff consider that the \$11,500 can be absorbed within existing budgets; and
- 5. approves a variation to the Fares Policy to incorporate central government four year fare reduction initiatives for children and youth nothing that the cost will be fully funded by Waka Kotahi; and
- 6. notes the initiatives by Tasman District Council to progress Community Transport Services; and
- 7. notes the changes to the Transport Advertising Guidelines in Attachment 1 to the agenda report.
